STIPULATION REGARDING
AMENDED COUNTERCLAIMS
AND SCHEDULING CONFERENCE**

1 The parties having agreed to a schedule for ICM to file amended
2 counterclaims and for Plaintiffs to respond thereto, and good cause appearing, the
3 Court hereby orders as follows:

4 1. ICM shall serve and file its amended counterclaims on or before
5 November 13, 2012.

6 2. Plaintiffs shall respond to ICM’s amended counterclaims on or before
7 December 7, 2012.

8 3. To enable the parties to have a more meaningful Rule 26(f) meeting
9 after the pleadings in this mater are settled, the Court continues the current Rule
10 16(b) scheduling conference from January 14, 2013 to February 25, 2013. The
11 parties are reminded of their obligations to disclose information and confer on a
12 discovery plan not later than 21 days prior to the scheduling conference, and to file
13 a joint statement with the Court not later than 14 days after they confer, as required
14 by F.R. Civ.P. 26 and the Local Rules of this Court. In their F.R.Civ. P. 26(f)
15 Report, the parties shall indicate whether they have agreed to participate in the
16 Court’s ADR Program, to private mediation or, upon a showing of good cause, to a
17 Magistrate Judge for a settlement conference. Failure to comply may lead to the
18 imposition of sanctions.
