 27 **TIME FOR DEFENDANT ZA**

ITS RESPONSE TO PLAINTIFF'S
FIRST AMENDED COMPLAINT

1 Plaintiff DotConnectAfrica Trust (“DCA”) and Defendant ZA Central
2 Registry, NPC (“ZA Central Registry”), by and through their counsel, hereby
3 stipulate as follows:

4 WHEREAS, on March 22, 2016, DCA served the operative First Amended
5 Complaint on ZA Central Registry at its headquarters in South Africa;

6 WHEREAS, ZA Central Registry’s response to the First Amended

16 has sufficient time to address jurisdictional and other issues raised by the First
17 Amended Complaint;
